### CANCELLATION, TERMINATION AND REFUND POLICY

The following refund policy applies to students who withdraw, cancel their Enrollment Agreement, have their enrollment terminated by the School or otherwise discontinue attendance at Philadelphia Technician Training Institute. Refunds are calculated based upon the "term", Terms are equivalent to one-half of the program. Terms may differ by program. Payments made in advance for future "terms" will always be refunded 100%.

If an applicant is rejected by the school before attending class, he/she will receive 100% refund of any posted payment made to tuition account for this enrollment.

If an applicant withdraws within 5 calendar days of signing the enrollment agreement, he/she will be entitled to a full refund of any posted payment made to his/her tuition account for this enrollment.

If an applicant withdraws after 5 calendar days of signing the enrollment agreement but prior to the program start, he/she will be entitled to a refund of any posted payment made to his/her tuition account for this enrollment less the registration fee.

Any student who withdraws from or discontinues the program during the first 7 calendar days of the term the student shall be refunded 75% of the tuition charges billed to his/her tuition account for this enrollment.

For a student withdrawing from or discontinuing the program after the first 7 days, but within the first 25% of the term, the student shall be refunded 55% of the tuition charges billed to his/her tuition account for this enrollment.

For a student withdrawing from or discontinuing after 25% but within 50% of the term, the student shall be refunded 30% of the tuition charges billed to his/her tuition account for this enrollment.

For a student withdrawing from or discontinuing the program after 50% of the term, the student is not entitled to a refund.
